

In-Service and refresher training is very important for police officers and is required to help mitigate potential liability on the village.


All police officers in the department have received the following training in 2021:

FISCAL MANAGEMENT

POLICE DEPARTMENT BUDGET:

- The Fiscal year 2021/2022 Police Department Annual Budget is <u>\$1,082,259</u> is approximately <u>24%</u> of the total Village budget. Excluding personnel costs such as health insurance, workers compensation insurance and retirement for full time employees.
- The police department budget does not contain "fluff" and the majority of the budget is for personnel costs.
- o \$114,410 of the police budget is for the Building Inspector



OVERTIME

Overtime:

- Overtime was a large part of personnel costs prior to 2020.
- Through proper schedule management and personnel recruitment, overtime costs have gone down tremendously.

The Tuxedo Park Police Department has added several programs for our residents this past year. In addition, we have partnered with other programs to provide additional services to our residents who may need them. The programs and services include:

- Project Child Safe- Free Gun Locks
- Unwanted prescription drug disposal services
- Community Well Check Program
- Vacant House Checks

CLOSING

In June of 2020 Governor Cuomo signed Executive Order 203: Police Reform and Reinvention Collaborative and in August this Executive Order along with a 135-page book of mandates and recommendations were distributed to all municipalities. The requirements are that a committee of community stakeholders review and amend police departments response to calls, change policies and procedures and formulate a new plan that the Village Board must adopt before April 1, 2021.

The Village formed a Police Reform Committee which consists of the following people:

- Stewart Rossenwasser, Orange County District Attorney's Office

The committee worked together and formulated a Police Reform Plan which the Village Board adopted and sent to Albany as required. This plan created positive changes in the police department including new and revised policies and procedures, more community policing and training for the police officers. Our committee continues to meet quarterly to evaluate police practices and plan for future events and changes. The Police Reform Committee are planning a Bicycle Rodeo and Community Day for Spring/Summer of 2022.

We are anticipating a February 2022 launch date for the new Safe Passage System which will bring more security to the Village. This system involves residents and authorized guests to be pre-screened and entered into our database to include their vehicle license plate numbers. When approaching the Main and South Gates, a License Plate Reader camera will communicate with the database and open the gate. All visitors who approach the gate who are not enrolled in the system will be thoroughly screened and vetted. This system will replace the current tag system that is currently in place.
