- 1) The Plaintiff, Daniel G. Castricone, Esq. is a resident of the state of New York. Mr. Castricone resides at 191 Maple Brook Road, Tuxedo NY 10987
- 2) The Defendant, Mrs. MARY VAUGHT is a resident of the state of New York. Mrs. Vaught resides at 17 Ridge Road Tuxedo Park NY 10987
- 3) A Facebook post was made by Mary Vaught on November 20, 2024. The published post was widely circulated throughout the town and surrounding area where the plaintiff resides and practices law.
- 4) Mr. Castricone is now and has been since July of 2024 the President of the Tuxedo Union Free School District Board of Education.
- 5) Mr. Castricone is now and has been since 2001 a member of the NY Bar in good standing practicing law from offices at 191 Maple Brook Rd in Tuxedo NY
- 6) In the post by Mary Vaught, she accuses Mr. Castricone of lying to the public about the payroll status of an employee of the district, Mr. Jeffrey White, who was placed by the board on unpaid FMLA leave in accordance with applicable law.
- 7) Based on information and belief, in the past, Mrs. Vaught has published similar defamatory allegations on social media.

8) The allegations made by Mary Vaught constitute allegations of Public Corruption, Misuse of Public Funds, Conspiracy, abrogation of oath of office and unethical behavior.

- 9) Defamation of the ethics of an attorney is a slander per se claim category of defamatory statements that are presumed to be damaging to the Plaintiff.
- 10) Mrs. Vaught had no evidence that the statements were true and knew or should have known that the statements were false
- 11) Mrs. Vaught acted negligently in failing to do any investigation into the veracity of her accusations before publishing them.
- 12) Mrs. Vaught acted intentionally in attempting to cause harm to the reputation of the Plaintiff Mr. Castricone.
- 13) Based on information and belief, Mrs. Vaught has conducted a campaign on social media of attacking the character of Mr. Castricone.
- 14) Based on information and belief, Mrs. Vaught has verbally used these false allegations to attack the character of Mr. Castricone.
- 15) The allegations made by Mrs. Vaught are false.
- 16) The Plaintiff, Mr. Castricone has at all times conducted himself and the business of the School Board, within the parameters of the law, ethically and responsibly.
- 17) Mr. Castricone denies all of Mrs. Vaught's allegations.
- 18) The Statements caused damage to the ethical reputation of the Plaintiff who is a practicing attorney and member in good standing of the NY Bar.
- 19) That Defendant, Mrs. Vaught was negligent, wanton, reckless, careless, willful and violated common-sense rules in allowing, causing, and/or permitting the social media posts to be published defaming and slandering the reputation, public perception and reputation among the school community of the Plaintiff and has done serious harm to the reputation, business prospects and employment prospects of the Plaintiff, Mr. Castricone. Through her actions Mrs. Vaught has caused emotional distress, upset and worry to Mr. Castricone and his family.
- 20) By her actions, Mrs. Mary Vaught has committed the torts of Slander, Liable, Defamation of Character and the intentional infliction of emotional distress upon Plaintiff Daniel Castricone.



As usual, they have scheduled an executive session for the middle of the meeting. These sessions often go on for hours and typically serve as a successful deterrent to public involvement and participation.
