VOTER REGISTRATION – GENERAL INFORMATION

Your voter registration must include a valid Tuxedo Park mailing address. This is especially true when you are registered with the Orange County (O.C.) Board of Elections (Goshen, NY). If your registration form or voter validation card is returned to the O.C. Board of Elections because it contains a mailing address that is not Tuxedo Park, your name appears on an Ineligible/Inactive List and you will not be allowed to vote in the Village election. You can verify your mailing address with the O.C. Board of Elections by calling 845-291-2444.

If you have moved within Tuxedo Park, and are registered through Orange County, you are still required to notify the O.C. Board of Elections of your address. If you are only registered in the Village, you should also attend Village Voter Registration Day and complete a new Village Voter Registration card to change your address. See below for date.

ABSENTEE BALLOTS

To qualify for an absentee ballot, a registered voter (must be on the O.C. Voter Registration List and/or the Village Voter Registration List), must be unavoidably absent from Tuxedo Park on Election Day (June 16th) because his/her duties, occupation, business or studies require him/her to be elsewhere, he/she will be on vacation elsewhere, or he/she is ill, is physically disabled or is in the hospital.

Absentee ballot applications can be picked up in the Village Office or are available on the Village of Tuxedo Park Website (www.tuxedopark-ny.gov).

Completed and signed applications for absentee ballots must be received in the Village Clerk's office by Tuesday, June 9th if the ballot is to be mailed back to the voter. The ballot being mailed to the voter by the Village Clerk must be postmarked no later than June 10th.

Applications for absentee ballots that are to be picked up in person by the voter or his/her agent must be received in the Village Clerk's office by Monday, June 15th. The ballot is immediately given to the voter or his/her agent.

No absentee ballot applications or absentee ballots are given out on Election Day.

All completed absentee ballots must be returned to the Village Clerk's office before the polls close at 9:00 p.m. on Election Day, June 16th.

VILLAGE VOTER REGISTRATION DAY

If you are not on the O.C. Voter Registration List or the Village Voter Registration List, you can register **IN PERSON** for the Village Election on Saturday, June 6th from 12:00 noon to 5:00 p.m. in the Village Hall. This registration only qualifies you to vote in Village elections.

You can only register on Voter Registration Day for eligibility to vote in the Village election. This registration cannot be done by mail or at any other time.

You can register as a qualified voter in Village, Town, County and National Elections by picking up a New York State (NYS) Voter Registration Form in any U.S. Post Office at any time, completing it, and returning it to the O.C. Board of Elections, Goshen, NY. If you want to register and qualify for the June 16th Village Election, the O.C. Board of Elections should receive your NYS Voter Registration Form by May 25th.
