- 2. Hartmann, 116 Tower Hill Rd. West At April 18th court date Village Judge advised property owner to submit a building permit to resolve violations and go before the Board of Architectural Review on May 21st. Property owner has failed to submit building permit application by May 10th deadline for the May 21st meeting.
- 3. Hatsis, West Lake Rd. DPW to cut tall grass and removal fallen tree.
- 4. Miller, E. Lake Rd. Sent letter dated March 21st to Linda Miller regarding Village Code 75-9 and 75-12. Failure to resolve the violation by April 22nd will result in an appearance ticket before the Village Justice Court. Met with owner's representative to mark trees that need to be cut/removed. Issued appearance ticket before Village Justice on June 20th. Violation outstanding since September 2018.
